Guest apartments

- Use of disinfecting products and health protocols to clean rooms, with particular focus on high-touch items.
- The high quality materials as well as the brand new equipment and furnishing are all easy to be cleaned and disinfect with the use of the latest innovation in cleaning technologies -steam cleaner and highest-grade disinfectants.
- A digital hosting directory will be send few days before your arrival with useful information regarding our area.
- We offer daily housekeeping. However room cleaning service will be provided upon request as well as the change of linen and towels, according to safety protocols in order to eliminate contact as much as possible. we advise our guests to inform us how often or when they wish to arrange their apartment cleaned.
- To minimize human contact we encourage our guests to complete the registration form via a link we will send you through our website.
- Contactless check in via a link we will share with you through our website
- We provide disinfectant dispensers for all our guests in public areas as well as in all our apartments
- Our textiles and towels are washed over 70o and treated according to the safety protocols.
- Each apartment is independent and features private veranda or balcony affirming your relaxation and privacy.
- Mariya art living is 40 meters from one of the most clean and uncrowded beaches of Kassandra.

Public spaces

- We have increased the frequency of cleaning and disinfecting in public spaces such as the furnished area of the garden, outdoor public showers, door handles, room keys to name a few.
- We have removed our front desk/reception outdoors.

Check in & check out policy

According to the new regulations, the check in time is altered to 15.00 pm and the check out to 11.00 am so, its apartment will be cleaned, disinfected and aired properly.

Health and safety protocols for our staff

-Our staff has been trained -according to their duties- in COVID19 protection and prevention, appropriate use of personal protective equipment, and implementation of emergency action plans.

-Daily screening - staff will undergo in daily temperature measurement (no record is kept for personal data protection purposes).

-All suppliers accessing our property must follow the required safety measures.

-For the purpose of public health protection, we keep a record of staff members and all guests staying at Mariya art living, including their name, nationality, date of arrival and departure, contact details, to enable contact tracing of any close contacts of covid-19 cases which may be subsequently identified.

Mariya art living, also, records and updates an event log book covid-19 (reception)

All guests and staff are informed that these records are kept for the protection of the public health, with regard to the processing of personal data GDPR and national law.
